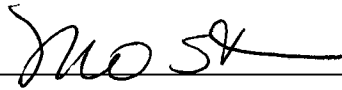
\$ 882.25 Cost of Extradition to the LCSO to be assessed. Court designates defendant a Sexual Offender. Designation Order to be filed. Defendant to register as a Sexual Offender upon release from custody. Defendant shall follow all terms and conditions of the Sex Offender Probation Order.

Court ordered monetary obligations, excluding restitution and specific Department of Correction fees, shall be paid directly to the Clerk of Court

Unpaid financial obligations still remaining 90 days after payment due date will be referred by the Clerk of Court to a collection agency and an additional fee of up to 40% of the outstanding balance owed will be added at that time (28.246). Failure to comply with payment of financial obligations may result in a suspension of your driver license privilege (322.245). Mandatory assessments are imposed and shall be included in the judgment without regard to whether the assessment was announced in open court.
