Your affiant DET FORD can truly state that:

1. Your affiant is a sworn Trooper of the Delaware State Police and is currently assigned to the Major Crimes Unit of Troop 3 - CIU.
2. On 02/13/20 [REDACTED] contacted Troop 3 to report sexual misconduct involving a youth leader at his church, S-John Sapp Jr (wmm 9/20/85). This case was referred to the Major Crimes Unit of Troop 3 - CIU for investigation and was subsequently assigned to your affiant.
3. On 02/17/20 your affiant spoke with [REDACTED] and his wife, [REDACTED] advised [REDACTED] Maranatha Fellowship church (which is located at 60 Deer Track Ln, Dover, DE 19904). They advised S-Sapp has been a Youth Leader at their church, Maranatha Fellowship, for approximately three years. They advised, during early morning hours of Thursday 2/13/20, they were contacted by S-Sapp who requested they immediately meet with him. They advised they responded to S-Sapp's residence at which time he confessed to "inappropriately touching" [REDACTED] 6-8 times (ref. complaint# 03-20-009060). They noted S-Sapp's wife, [REDACTED] was also present during S-Sapp's confession.
4. [REDACTED] advised, after his meeting with [REDACTED], he became aware of an additional member of the youth group at his church who may have had a similar relationship with S-Sapp; 17yoa [REDACTED]
5. On 2/18/20 your affiant interviewed [REDACTED] who advised S-Sapp is her youth leader at Maranatha Fellowship. [REDACTED] advised she has been a member of the youth group at Maranatha Fellowship for 4 years. [REDACTED] noted her youth group met regularly on Wednesday nights.
6. [REDACTED] advised she became engaged in a secret sexual relationship with S-Sapp starting in January 2019 when she was 16yoa. [REDACTED] advised their sexual relationship continued until approximately three weeks prior to this interview (January 2020). [REDACTED] advised their sexual acts included performing oral sex on each other, masturbating each other. S-Sapp would rub his penis on her vagina, and S-Sapp would grope her breasts. [REDACTED] advised their sexual encounters would occur approximately twice a month or more.
7. [REDACTED] advised the sexual acts would often occur inside S-Sapp's truck. [REDACTED] advised they have had sexual interactions at S-Sapp's residence located at [REDACTED] [REDACTED] advised some of their sexual interactions have occurred inside S-Sapp's truck parked at DelTech in Dover DE [REDACTED] advised they have had sexual interactions at her residence located at [REDACTED] [REDACTED] advised the sexual interactions occurred at other various locations.

8. During her interview, [REDACTED] described details of several of her sexual encounters with S-Sapp including three instances during which they engaged in oral sex and other acts of sexual contact.
9. Your affiant notes, based on [REDACTED] date of birth, [REDACTED] was 16 years of age in January 2019 when the sexual relationship between [REDACTED] and S-Sapp began. During that time, S-Sapp was 33 years of age.
10. Your affiant has attempted to contact S-Sapp to conduct and interview. Your affiant was contacted by S-Sapp's attorney who indicated S-Sapp will not be providing a statement at this time.
11. Your affiant notes that S-Sapp, who was a youth leader of a youth group, was in a "position of trust" with
12. Your affiant affirms that the above statements are accurate and requests that a warrant be issued for the above listed charges.
